- 3. Building/Maintenance below budget no significant expenses.

Property Search team – Matt

- Committee has begun meeting twice weekly immediately after service on Sunday and via zoom on Thursdays.
- Real Estate Agent has provided a list of commercial properties for lease to consider
- Members have list of other properties to consider as well from congregant suggestions and committee efforts
- Priority is being given to determining feasibility of leasing Melbourne Heights space. Chuck Fulner is pursuing this possibility.

Sale of Building - Dave

• The sale is proceeding and the closing date is anticipated to occur in October. The Buyer had been awaiting a HUD release on its own building before it could sell it. Dave will continue to follow up.

Other business

- Rev. David discussed his intentions for helping the congregation through transition. This included work with both the Board and the congregation including classes and potential workshops. One of the classes referenced was "15 Commitments of Conscious Leadership."
- Rev. David will send out an email with the potential classes and proposed calendar for the Board to view.

- Rev. David referenced the creation of a Transition Council outside of Board members to provide him feedback and advice. Volunteers will be sought and persons contacted to seek their participation. Linda will lead the effort.
- Matt brought up the potential of having a Unity picnic and offered to host it at his house in Bardstown in September on one of the Sundays that Rev. David will be here. Concern was expressed about there being so many calendar commitments.
